

**Forecaster Challenge: Official Rules**  
**No Purchase Necessary to Participate**

**The Game:** Forecaster Challenge (the “Game”) consists of an interactive virtual trading game, provided by Cantor Futures Exchange, L.P. (“Cantor”). The object of the Game is to allow Participants to practice virtual trading of “Contracts” based on the weather at a specific location, during specific time periods, as reported by AccuWeather, Inc. (“AccuWeather”). The Game is skill-based. Cantor will have exclusive right to determine the weather outcomes at each location, for each time period, and the value of all Contracts that remain open in a Participant’s portfolio at the end of each time period.

**Eligibility:** There is no purchase necessary to participate. Participants are required to agree to the [Terms of Use](#) and [Privacy Policy](#). Becoming a Participant in the Game does not indicate that a Participant qualifies to become a Participant of the Cantor Futures Exchange.

**Registration and Game Play:**

- 1) Visit <https://www.accuweather.com/en/forecaster-challenge/> (the “Site”) and fully complete and submit the Registration (“Registration”) according to the instructions provided to become a Participant (“Participant”). Participants will be required to provide their Email Address on the Registration along with all other required fields in accordance with the instructions provided to create their Account (“Account”). Nicknames may not be vulgar, offensive, or intended to misrepresent you or your Account as another party. Any Accounts with Nicknames deemed inappropriate may be disabled at the sole discretion of Cantor. Email Address and other required Participant information to be used as outlined in the [Terms of Use](#) and [Privacy Policy](#). Limit (1) Registration per person and per email address. Additional Registrations received from any such person or email address after the first Registration received from that person or email address will be void. Incomplete Registration and/or Registration containing inaccurate information will be void at Cantor’s sole discretion. There is no financial obligation required to complete the Registration. The use of script, macro or any device to automate or subvert the Registration and/or participation process is prohibited and all such Registrations will be void.
- 2) Upon completion of the Registration each Participant will receive an initial balance of AccuDollars in their Account to use for gameplay. AccuDollars are not valid currency, have no cash value and are used for entertainment purposes only on the Site. Please see the [Terms of Use](#) for a complete description of AccuDollars.
- 3) Following Registration, Participants will be able to proceed to the weather-type themed pages and may submit predictions on the weather at a location chosen by the Participant, during the Participant’s chosen time period by following the instructions provided, to begin virtual trading activity.
- 4) Submitting predictions will cause the balance of AccuDollars in your Account to be reduced by the amount described when you submitted the prediction. If your prediction is correct, the balance of AccuDollars in your Account will be increased by the amount described when you submitted the prediction. Certain other actions within the Game, such as logging into your Account on a regular basis, may cause the balance of AccuDollars in your Account to be increased. These actions will be described within the Game interface.

**Miscellaneous:** Cantor, in its sole discretion, reserves the right to modify, suspend or terminate this Game (or any portion thereof) for any reason, including should virus, bugs, non-authorized human intervention or other causes, corrupt or impair the administration, security, fairness or proper play of this Game.
